Revisions to the Constitution and Bylaws were distributed. Each revision was presented to the membership and voting was done verbally. All revisions were passed.

### **12. Resolution Committee Report - Walter Pichon**

The resolutions were distributed. A motion to dispense with the reading of the resolutions was made by Claude Lewis, seconded by Sharon Parker and passed. Resolutions 1, 2, and 3 were voted on verbally and passed. Jodi Miller moved and Don Brandon seconded that we bring the fluoridation issue to the floor for discussion, motion passed. The floor was opened for discussion. James Miller spoke for the fluoride resolution. Resolution 4 (on fluoridation) was voted on and passed. The proclamation naming the 4<sup>th</sup> Monday of April annually as National Sanitarian/Environmental Health Specialist Day was distributed to the members.
