## **A REPORT ON NEHA**

By the time most of you get this newsletter, I will be in Denver for a NEHA Office Review and Board of Directors Meeting. Many exciting things have been happening at NEHA the past few months. NEHA is proud to boast that our relationship with CDC, ASTDR, FDA, and EPA have never been stronger and this has lead to Annual Educational Conference Support for activities of mutual interest from FDA and CDC. Also these agencies have provided NEHA with unprecedented grants for which NEHA must produce such things as "Course Curriculum for IAQ Education for Environmental Health Professionals," and "The Basis of Bloodborne Disease Epidemiology." NEHA has continued to educate and provide credentials for those in IAQ, especially in the areas of Radon Risk Reduction and Asthma Awareness. ASTDR has provided funds for

the development and presentation of workshops designed to raise the level of awareness of Nuclear, Biological, and Chemical Preparedness issues for Environmental Health Professionals.

If you take time to visit the NEHA website which is linked to our LEHA Website, you will find a truly remarkable document, nearly 80 pages, that addresses the issue of environmental issues related to the collapse of the Twin International Trade Towers in New York on 9-11. This document covers the activities of Environmental Health Professionals during this time. It was funded by a generous gift from our public and environmental health colleagues from Great Britain, who were having their national educational conference on the day of the attack. 

Special emphasis will be on activities and relationships with the new Homeland Security Department, after all we want our members to be the best trained professionals should, God forbid, another tragedy like 9-11 or worse might occur. We want our Environmental Health Professionals to be “Public Health Ready” through appropriate training and preparation and planning for these unthinkable events.

Lastly the 2004 Educational Conference (AEC) planning and preparation are well under way. This year’s conference will be held in Anchorage, Alaska. We have received a record number of abstracts from potential speakers and this bodes well for a large attendance. Also we have been making plans to welcome some 250 plus Alaskans to our conference, in addition to our normal attendees. The airfare costs are not really high if you plan early. Hotel prices are about what we have been used to in the Continental U.S. The quality of papers is very high and we probably will have to up-size our Poster Presentation Program to accommodate all the presentations. Also there will be some fun trying to find the little ball in the white snow “Golf Tournament.” NEHA is planning to sponsor a “Fishing Expedition” for a small fee into the wilderness of Alaska. There is also planned a very reasonably priced (from \$850 per person) post-conference “Inside Passage Cruise” from Seward to Vancouver, B.C.

Plan to come and enjoy the wildlife, scenery, educational opportunities, and great fellowship in Anchorage, Alaska in May 2004. Hope to see you there!
