**PURPOSE**

To honor exemplary accomplishments performed by a professional in the field of environmental health, protection, management or regulation.

**CRITERIA AND QUALIFICATIONS**

1. Employed within the field of environmental health, protection, management or regulation.
2. Demonstration of interest and accomplishment in the field of environmental health protection, management or regulation.
3. Represents an exemplary level of professionalism.
4. Nominee for the Award must be a person whose primary source of income is derived from the practice of environmental protection.
5. Must be a LEHA member in good standing.
6. Award shall be issued only once per individual.

**NOMINATIONS**

1. Nominations for the Environmental Professional Award must be submitted by a LEHA member in good standing.
2. Must be submitted to the Chairman of the Awards Committee prior to the last Board of Directors meeting of the year.
3. In the absence of nominations, the Board may nominate and conform without time limitations.
4. In any event the Board may elect not to confer the award.

**SELECTIONS**

1. Nominee's criteria and qualifications to be considered cumulatively by the Awards Committee.
2. The Awards Committee's first choice including documentation to be submitted to the Board of Directors at the last board meeting of the year for consideration and Concurrence or rejection.

**AWARD**

In the form of an engraved plaque the cost of which to be derived from the treasury of LEHA and to be presented at the Annual Education Conference.
